(2) Invalid Condition - Fields 261D, 262D and 264D are invalid if:

- The field is more than 1 character.
- The field is not blank, A, B, C, D, E or F.
- The tax period is before 201901.

(3) Field 263D - Form 8997 - Special gain code.

(4) **Invalid condition** - Field 263D is invalid if:

- The field is more than 1 character.
- The field is not blank, or "A through Z".
- The tax period is before 201901.

#### (3) Correction Procedures:

- a. Correct coding errors, transcription errors, and misplaced entries.
- b. Compare the displayed fields with the return and attachments. If incorrect overlay the screen with the correct information.
- c. The Taxpayer will attach Form 8936 Schedule A, Clean Vehicle Credit Amount and report their credit on Form 1065, Line 29.
- e. If the return was e-filed and Field 311IN or Field 312IN are "1", then send TPNC 74.

**Caution:** Due to a programming issue, send a non-suspense Letter 3024C to advise the taxpayer of the math error.

f. If a math error is present and transcription is correct, then send TPNC 74.

**Caution:** Due to a programming issue, send a non-suspense Letter 3024C to advise the taxpayer of the math error.

g. Valid TPNCs for Error Code 729 are TPNC 74 & 90.

#### (4) Suspense Correction

• If **No Reply** to correspondence, then enter CCC "3" and send TPNC 74.

**Caution:** Due to a programming issue, send a non-suspense Letter 3024C to advise the taxpayer of the math error.

### (3) Correction Procedures

- a. Correct coding error, transcription errors, and misplaced entries.
- b. Compare the displayed fields with the return and attachments. If incorrect, overlay the screen with the correct information.
- c. If a discrepancy of **# Constant of #** between the taxpayer's figures and the computer's figures still exists after all actions above for math verification have been taken and all the necessary corrections have been made send TPNC 75.

**Caution:** Due to a programming issue, send a non-suspense Letter 3024C to advise the taxpayer of the math error.

d. Valid TPNCs for EC 730 are 75 and 90.

### (3) Correction Procedures

- a. Correct coding errors, transcription errors, and misplaced entries.
- b. If Fields 231BI. 231GI, 241OI, or 241XI are blank enter the amount from 231BH, 231GH, 241OH or 241XH.
- c. Compare the displayed fields with the return and attachments. If incorrect overlay the screen with the correct information.
- d. The taxpayer will attach Form 3800 General Business Credit, and report their EPE credit on Form 1065, Line 29.
- e. If Form 3800, General Business Credit, is not attached and the EPE credit claimed on Form 1065, Line 29 is **# 1000 attached #** then SSPND with Action Code 211 and correspond using Letter 1355C.
- f. If a discrepancy of **# second and #** between the taxpayer's figures and the computer's figures still exists after all the actions for math verification have been taken and all the necessary corrections have been made send TPNC 73.

**Caution:** Due to a programming issue, send a non-suspense Letter 3024C to advise the taxpayer of the math error.

g. Valid TPNCs For EC 731 are 73 and 90.

### (4) Suspense Correction:

 If No Reply to correspondence, then disallow the EPE credit shown and remove the amount claimed from Field 07EPE. Enter CCC" 3" and send TPNC 73

**Caution:** Due to a programming issue, send a non-suspense Letter 3024C to advise the taxpayer of the math error.

#### (3) Correction Procedures

- a. Correct coding errors, transcription errors, and misplaced entries.
- b. Compare the displayed fields with the return and attachments. If incorrect overlay the screen with the correct information.
- c. If you are processing a 2022 Tax Year Form and the taxpayer has indicated an "Elective Payment "or "Deemed Payment" by writing "IRA22DPE" on an attachment or on Form 1065, Line 29 dotted portion, refer to the instructions found at IRM 3.12.15.2.16, Elective Payment Election (EPE) and Credit Transfers.

**Note:** Do not continue processing return. Ensure that Action Code 450 is entered and the return with EPE is held for LB&I review.

- d. If there is an amount present on Form 1065, Line 29 and Form 3800, is not attached, SSPND using Action Code 211 and correspond using letter 1355C.
- e. Form 1065, Line 29 has an amount and Form 3800, is attached, and the Taxpayer has figured or transferred Part III Form 3800 incorrectly send TPNC 73.

**Caution:** Due to a programming issue, send a non-suspense Letter 3024C to advise the taxpayer of the math error.

f. If a discrepancy of **# the second and #** between the taxpayer's figures and the computer's figures still exists after all actions above for math verification have been taken and all the necessary corrections have been made send TPNC 73.

**Caution:** Due to a programming issue, send a non-suspense Letter 3024C to advise the taxpayer of the math error.

g. Valid TPNCs for EC 739 are 73, 76 and 90.

(4) Suspense Correction:

• **No Reply** to correspondence, then disallow the amount claimed in Field 07EPE. Enter CCC "3" and send TPNC 76.

**Caution:** Due to a programming issue, send a non-suspense Letter 3024C to advise the taxpayer of the math error.
