

# MINUTES Internal Revenue Service Advisory Council Public Meeting

September 5, 2024, 3 p.m. ET

**Meeting Called to Order:** John Lipold, Designated Federal Officer, called the meeting to order and turned the meeting over to IRSAC Chair Annette Nellen.

## **Introduction by IRSAC Chair Annette Nellen:**

The IRSAC is an advisory body to the IRS Commissioner and agency leadership. This group consists of 32 volunteer members appointed by the IRS who represent a broad range of tax interests and areas of expertise and practice. The IRSAC provides an organized forum for discussion of tax administration issues between IRS officials and representatives of the public. The IRSAC reviews existing tax policy and administrative issues and makes recommendations to achieve efficient and effective tax administration. Topics addressed by the IRSAC arise from both the IRS and IRSAC members.

The IRSAC members work within five broad subject matter groups. These subgroups are Information Reporting, Large Business & International, Small Business/Self-Employed, Tax-Exempt/Government Entities, and Taxpayer Services (formerly named Wage & Investment).

Today's public meeting will discuss issues and recommendations for inclusion in this year's public report to be released in November.

At our May 8 public meeting, we approved 6 general issues and 22 subgroup issues. At our July 17 public meeting, we approved 7 general issues and 2 subgroup issues. One of our general issues approved at the May 8 public meeting has been converted to a comment letter because the IRS wants our comments before publication of our report in November. In addition to voting on two additional issues at today's meeting, we will also state the titles of all our approved issues with a summary of our recommendations for each.
