This letter responds to a letter dated May 1, 2002, by your authorized representative on behalf of \underline{X} , requesting a ruling under § 1362(b)(5) of the Internal Revenue Code.

FACTS

<u>X</u> was organized as a limited liability company under <u>State</u> law on <u>d1</u>. <u>X</u>'s shareholders, <u>A</u> and <u>B</u>, decided that <u>X</u> would be an S corporation, effective <u>d2</u>. <u>X</u> timely filed Form 8832, Entity Classification Election, requesting that <u>X</u> be classified as an association taxable as a corporation effective <u>d2</u>. <u>A</u> and <u>B</u> believed that <u>X</u>'s tax adviser had filed <u>X</u>'s Form 2553, Election by a Small Business Corporation. However, <u>X</u>'s Form 2553 was not filed timely.

PLR-148062-02

<u>X</u> requests a ruling under § 1362(b)(5), that its § 1362(a) election will be treated as timely made for its taxable year that began on d2.

LAW AND ANALYSIS

Section 1362(a) provides that a small business corporation may elect to be an S corporation.

Section 1362(b) provides the rule on when an S election will be effective. Generally, if an S election is made within the first two and one-half months of a corporation's taxable year, then the corporation will be treated as an S corporation for the taxable year in which the election is made. Section 1362(b)(3) provides that if an S election is made after the first two and one-half months of a corporation's taxable year, then the corporation will not be treated as an S corporation until the taxable year after the year in which the S election is made.

Section 1362(b)(5) provides that if (1) an election under § 1362(a) is made for any taxable year after the date prescribed by § 1362 for making the election for the taxable year or no § 1362(a) election is made for any taxable year, and (2) the Secretary determines that there was reasonable cause for the failure to timely make the election, then the Secretary may treat the election as timely made for such taxable year and § 1362(b)(3) shall not apply.

<u>CONCLUSION</u>

Based on the facts submitted and representations made, we conclude that \underline{X} has established reasonable cause for failing to make a timely S election and that \underline{X} is eligible for relief under § 1362(b)(5). Accordingly, if \underline{X} makes an election to be an S corporation by filing with the appropriate Service Center a completed Form 2553, containing an effective date of $\underline{d2}$ for the election, within 60 days following the date of this letter, then such election will be treated as timely made. A copy of this letter should be attached to the Form 2553 filed with the Service Center. A copy is enclosed for that purpose.

Except as expressly provided herein, we express or imply no opinion concerning the federal tax consequences of any aspect of any transaction or item discussed or referenced in this letter. Specifically, we express or imply no opinion concerning whether \underline{X} is otherwise eligible to be an S corporation for federal tax purposes.

Pursuant to a power of attorney on file with this office, we are sending a copy of this letter to your authorized representative.

This ruling is directed only to the taxpayer who requested it. Section 6110(k)(3) of the Code provides that it may not be used or cited as precedent.
