



Section 41(f)(1)(A) provides that in determining the amount of the credit under § 41-- (i) all members of the same controlled group of corporations shall be treated as a single taxpayer, and (ii) the credit (if any) allowable by § 41 to each member shall be its proportionate shares of the qualified research expenses and basic research payments giving rise to the credit.

Based solely on the facts and representations made, we conclude that Corporation and its § 41(f) controlled group may calculate the research credit for the taxable year ending on z, and all succeeding years, under the standard method of § 41(a), without regard to § 41(c)(4), provided that Corporation does not make an election to determine its research credit under the AIRC rules of § 41(c)(4) in a later year.

Except as expressly provided herein, we express or imply no opinion concerning the tax consequences of any aspect of any transaction or item discussed or referenced in this letter. Further, we express or imply no opinion concerning expenditures Corporation, or any member of its § 41(f) controlled group, treated as qualified research expenses.

This ruling is directed only to the taxpayer requesting it. Section 6110(k)(3) provides that it may not be used or cited as precedent.
